

**Agistment available at Watagan Grange for clients sending horses
for agistment & schooling with Rebel Morrow**

Agistment Costs

- ∞ Individual paddocks, automatic water feeders, wood & wire fencing with electric stand-offs & shelters.

Cost \$140 (inc GST) per week or \$25 (inc GST) per night
(including feeding x 2 day & rugging)

- ∞ **If horse is being sent for schooling (minimum 3 rides a week):**

Cost \$120 (inc GST) per week or \$22 (inc GST) per night
(including feeding x 2 day & rugging)

Schooling Costs

- ∞ **Weekly** – 7 rides @ \$45 (inc GST)
- ∞ **Fortnight** – 12 rides @ \$40 (inc GST)
- ∞ **Monthly** – 25 rides @ \$35 (inc GST)

**The minimum number of rides for schooling is 3/week after that it is negotiable
and the client will be charged per ride.**

Consents:

CONDITIONS OF CONTRACT FOR AGISTMENT

PAYMENT

The owner agrees:

- ∞ To pay all fees and charges as agreed monthly/ weekly in advance as agreed.
- ∞ In the event that agistment fees or other fees are unpaid, the owner grants a lien to Rebel Morrow over the horse so that the horse may not be removed from the Watagan Grange until outstanding fees are paid in full.
- ∞ In the event that agistment fees or other fees remain outstanding for a period of 30 days, the owner hereby irrevocably appoints Rebel Morrow to be the owner's attorney to sell the horse at public auction.
- ∞ Rebel Morrow will give a written notice to the owner of her intention to sell the horse at public auction after 7 days.
- ∞ On sale of the horse at public auction the proceeds of sale will be applied (after deduction of sales commissions and expenses associated with such sale) firstly against all agistment fees outstanding to the date of the sale and secondly against any other agistment fees outstanding by the owner in relation to any other horse that the owner has on agistment at Watagan Grange and thirdly the balance, if any, to be paid to the owner.

Damage to horse or by horse:

- ∞ The owner is responsible for any damage caused by the horse whilst at agistment at Watagan Grange and accepts all the risks of injury to the horse. It is recommended that the horse be insured with a reputable insurance company against injury to or loss of the horse or damage done by the horse to property including other animals.

Dispute Resolution:

- ∞ It is in everyone's interest particularly that of the horse, to resolve all issues amicably. The owner and Rebel Morrow agree to negotiate, in good faith, any issue arising out of this contract.

Termination:

- ∞ This contract will terminate at the end of the agreed period or
- ∞ By either party giving the other party 48 hours notice in writing of termination.
- ∞ If notice of termination is given by either party, the owner agrees to make arrangements for the transportation of the horse at the owner's expense. If the owner does not make arrangements for the transportation of the horse within 48 hours, Rebel Morrow may make arrangements for the transportation of the horse and any cost incurred will be an additional charge under this contract and recoverable under this contract.

Disclaimer:

Please note that while every reasonable attempt will be made to ensure the horse's wellbeing, the owner leaves their horse here at their own risk.
